Unless otherwise stated, capitalised terms in this Announcement have the same meanings as defined in the prospectus of the Trust and the Sub-Fund dated 6 September 2022 (the "**Prospectus**").

Nikko Asset Management Hong Kong Limited (the "Manager"), the manager of the Trust and the Sub-Fund, hereby wishes to inform Unitholders that Singapore Exchange Limited (the "Index Provider"), being the index provider of iEdge-Factset Global Internet Index (the "Index"), which is the underlying index of the Sub-Fund, has introduced certain changes to the methodology of the Index which will take effect after market close on 23 September 2022 (the "Effective Date"), such changes to be implemented on 26 September 2022.

With effect from the Effective Date, the sector eligibility criteria under the Index methodology is revised such that "Handheld and Smart Phone Games Software" (under the Revere Business Industry Classification System (RBICS) provided by the Index Provider's research partner, FactSet) is added as an eligible business segment for inclusion in the Index (the "Index Change") to better represent the Internet segment. The updated Index methodology is available at https://www.sgx.com/indices/products/ifid (this website has not been reviewed by the SFC).

The Index will be rebalanced on 26 September 2022 (the "**Rebalance Date**") to reflect the Index Change. The portfolio of the Sub-Fund will be rebalanced on or around the Rebalance Date to reflect the changes to the Index constituents (if any) as a result of the Index Change.

For the avoidance of doubt, there are no changes to the Index methodology other than the Index Change. The investment strategy and risk profile of the Sub-Fund do not change.
